Catch Loch Leven – Statement of Support

We write as the four elected members for Ward 8 (Kinross-shire) in support of the proposals to explore further the possibility of a district heating system for Kinross-shire, utilising a water-based heat exchange system in Loch Leven.

We recognise the importance of addressing climate change as a matter of urgency and that is why it is important to be ambitious, bold and explore new technologies to decarbonise how we heat out homes. That said, we are aware that the use of both district heating systems and water-based heat exchange systems are proven technologies and used in other parts of the world such as Denmark.

Furthermore, having been independently identified as a potentially suitable site, we recognise that such a system at Loch Leven, in addition to helping to tackle climate change, would bring both social and economic benefits to Kinross-shire through lower energy bills and increased jobs.

Whilst any development of this nature would need to be subject to extensive community engagement and fundraising, as well as the planning and regulatory systems, we do commend the extensive work taken thus far by Catch Loch Leven. Therefore, we are happy to support the efforts to move to the project to the next steps, in particular to better assess the feasibility of such a scheme.

We do hope this letter of cross-party support will be of assistance to the project and we look forward to supporting Catch Loch Leven in the future.

Dear David,

I am pleased to send you this statement of support on behalf of KCC.

CATCH are working on a local heat and energy efficiency strategy which involves utilising Loch Leven as a heat source and supplying energy by means of underground pipes to homes in Kinross.

60% of PKC households are now defined as being in fuel poverty. We are in a climate crisis, and need to find new energy sources. While heat pumps are a great source of renewable energy, two-thirds of houses would require a major upgrade in order for their installation to be successful.

District heating is not a new idea: it has been successfully implemented elsewhere, mostly in Europe. These systems providing low cost, low carbon energy to local communities and the technologies are well proven.

Loch Leven is currently under stress. Climate change is driving rising temperatures, combined with long standing issues of nutrient run-off which are changing the eco-system balance.

CATCH are looking to consult with the wider community about their project.

Kinross Community Council is happy to encourage them to keep going with their work on the project and wishes them success with public consultation work.
